### SCHEDULE 3 PART 1

#### OVERALL REQUIREMENTS

#### 1 OPERATIONS

##### 1.1 Overall Requirements

The Scottish Ministers have resolved to support community planning in terms of the Local Government in Scotland Act 2003 and the Operating Company shall provide such support and the like and attend such meetings as required by the Director in this regard.

Subject to the other provisions of this Contract in the planning and execution of all Operations and Works associated with the management and maintenance of the Unit the Operating Company shall take all such action as shall be necessary in the circumstances and do all such things to ensure and in such a manner as shall secure but shall not be limited to the following

- (i) the safety of
  - (a) the Operating Company's employees
  - (b) road users or
  - (c) any other persons on the Unit or on land adjacent to the Unit.
- (ii) that the ability of the Scottish Ministers to perform Statutory Functions and statutory duties in relation to the Unit shall be unimpaired and subject to sub-paragraphs 1.1(i) and (ii) of this Part 1 of this Schedule 3 that
- (iii) using all reasonable endeavours delay to road users shall be minimised
- (iv) the risk of adverse effects on the environment and on the amenity enjoyed by
  - (a) the owners and occupiers of land adjacent to the Unit
  - (b) to road users and
  - (c) to users of adjoining roads and facilities.shall be minimised
- (v) all accidents and Emergencies shall be responded to as quickly as possible and in accordance with this Contract including but not limited to the various Schedules and their adverse effects on road users shall be minimised
- (vi) risk of damage to or destruction of third party property within or outwith the Unit shall be minimised
- (vii) members of the public and all other road users shall be treated with due courtesy and consideration
- (viii) road users shall be given adequate information and forewarning of any events on or any matters affecting the Unit such as shall be reasonable to

enable them to minimise any adverse consequences on themselves of such events or matters

- (ix) members of the public and others shall be given adequate opportunity to bring to the attention of the Operating Company any matters affecting the ability of the Operating Company to meet the requirements of this Contract and
- (x) data relating to the operation and maintenance of the Unit and events on the Unit shall be collected by the Operating Company and given to the Scottish Ministers in accordance with the requirements of this Contract.
