### Comments::

The Mobility and Access Committee for Scotland (MACS) is pleased to contribute to the consultation and welcomes the proposal to have an equivalent Scottish scheme in place in advance of the delivery of Disability Assistance.

MACS believes in a Scotland without the barriers that isolate and exclude disabled people from making their choice of successful door to door journeys. MACS overarching strategic remits include providing advice to Scottish Ministers on the transport and travel needs of disabled people and in doing so, engaging with disabled people and/or their representatives to gather insights from their experiences to give advice.

MACS would encourage the new devolved Scottish Social security arrangements to support the continuation of Motability and in reference to 4.14- Access to Accessible Vehicles Leases and Equipmentwithin the consultation, there are social security benefits that act as administrative eligibility criteria for other travel schemes. Social security benefits such as Attendance Allowance, Disability Living Allowance and Personal Independent Payments provide a gateway for 'companion' concessionary travel permit. MACS would strongly recommend that the social security benefits be carefully researched and understood in relation to diverse groups such as older people groups dependant on travel schemes.

MACS would also suggest the VAT exemption regulations be considered. For example, it is the VAT status of benefits, rather than wider considerations that decide which benefits confer entitlement to Motability. Recently, Disability Equality Scotland conducted a weekly poll with their members on the topic of Motability and in summary the poll opinion raised a number of concerns including the concern that Motability staff are not in touch with the needs (and challenges) of disabled people, particularly in Scotland and that now benefits have been devolved, there is perhaps a stronger argument for Social Security Scotland to be involved. The poll emphasised there is a strong view that the Scottish Government should work in partnership in ensuring the new devolved social security arrangements consider the transport and travel needs of disabled people.

MACS strongly advocates that social security policy should recognise that social security entitlements often act as a gateway to mobility/transport i.e. encourage the consideration of the passported benefits which social security entitlements provide. For example, the concessionary travel scheme enables independence, accessibility and social inclusivity for disabled people.
