The proposal is an order with the title "The A87 Trunk Road (Portree to Prabost) (Temporary Prohibition on Use of Road) Order 2025. This order allows part of the A87 trunk road to be closed for a period of time on 14<sup>th</sup> June 2025 when the type of traffic sign specified in the order is displayed (and see the schedule of the order for the specific length of road to be closed). This means that no person may use, or authorise the use of, any vehicle on that specific length of road during that period. The only exceptions are for emergency vehicles and vehicles involved in holding the relevant event. The order will not prevent pedestrians from using that length of road at any time. The closure of this part of the A87 it to facilitate the safety of participants and viewers of the Skye Half Marathon.

During the closure of this section of road access to Portree Community Centre, Portree & Bracdale Free Church of Scotland, Church of St Mary & Our Lady of the Assumption Church, UHI Norther, West & Hebrides, Portree Primary School, Portree High School, Bun-sgoil Ghudhlig Phot Righ, Portree Community Hospital, Lets Smile Dental Care of Portree Dental Care Ltd, Portree Medical Practice, Church of Scotland Kesalye, Uig Misson Church and Uig Free Church will be impacted. All other local routes remain open. Emergency vehicles will not be impacted during this closure. Additionally, the closure will occur for a short time. The closure is to maintain safety for the Skye Half Marathon. Access for all emergency services will be maintained at all times. The closure will not restrict pedestrians at any time.

Although some of these facilities directly accessed from within this section of road and all other local access routes remain open, pedestrians are still able to access all venues by foot and the event is taking place at the weekend when most of these venues will be closed. Therefore, this order is not relevant to any restrictions to articles 14, 24, 28 or 31. Local access routes remain open, the event is well publicised and is taking place for a short period of time.

To ensure the safe running of this event, parts of the A87 road will be closed for approximately 2 hours.
